a. Approval - Terex Bucket Truck Rebuild

Mr. Brian Thompson presented a request to have Terex Services rebuild the 2003 material handling bucket truck. He explained that rebuilding the aerial unit will give a minimum of five more years of service from the unit. Mr. Thompson explained the Terex quote amount to be \$47,372.31 for repairs, with a 5-year warranty. He is requesting approval for the amount of \$55,000.00 to cover any unforeseen problems which may arise once the truck is disassembled. He explained that a new unit would cost approximately \$200,000.00. The purchase order would be issued for the amount of the quote, and the approved overage would only be used if required. There is only one quote due to Terex being the manufacturer which built the unit. He explained the cost would be funded by MCT.

Council discussed the difference in the quote amount, the amount requested for approval, and the warranty on the repairs.

The Committee recommends to Council approval for Terex Services to rebuild the bucket truck for an amount up to \$55,000.00.
