MOTION/RECOMMENDATION:

Recommend Council APPROVE \$46,000.00 for the purchase of materials and labor to construct a live fire training facility at GUTA.

BACKGROUND:

Whereas the City of Monroe has continually sought to upgrade and improve the quality of training of our public safety personnel, \$30,000.00 was approved in the 2016 Fire General Fund CIP for the construction of a live fire training facility. During our review of the training facility and it's capabilities we found that for an additional \$16,000.00 we could add a third level with an additional set of outside stairs and a platform for tactical training for both Fire and Police.

After reviewing the potential positive effects on training, ISO impact, and overall Public Safety benefit to the City of Monroe, I request a Budget Amendment that reduces 550-541300 by \$16,000.00 and increases 530-541300 by \$16,000.00 to facilitate the construction of this multipurpose Public Safety Training building. The amendment will leave a balance of \$19000.00 in 550-541300 for Capital improvements.

This proposal is for all material (unless noted), equipment and labor needed to install 6 shipping containers as per directions of City Of Monroe personal.

Concrete footings will be prepared with steel weld plates and boxes will be set onto footings and welded.

The bottom boxes will be side by side with a 14' clearspan opening cut in to allow for larger room.

Boxes will be stacked 3 high in the center.

4 flights of steel stairs will be needed (2 interior and 2 exterior) With top landing, handrails and toe plate.

5 walk through steel doors will be installed, and 4 window openings will be installed.

Burn box with 2x2" steel tube and sheet will be installed.


All the above listed will total \$ 24,600.00 using boxes provided by the City Of Monroe and on a prepared graded site.


A forced entry door can be added at a cost of \$ 3220.00 Shooter platform that extends past the top level of the boxes (8') With an additional set of stairs, railings and toe plate, can be added at a cost of \$ 9140.00.

Roof to the shooter platform can be added at a cost of \$ 2850.00.
