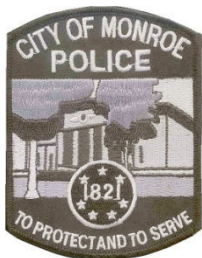

# Memorandum

To: Public Safety Committee

I respectfully request that the \$70,000.00 that will be received from MHA for extra patrol be used to purchase and equip three vehicles for use in Uniform Patrol and CID. We currently have thirteen vehicles with over 90k miles; eight of these have over 100k miles. We will have two officers returning from military leave in the Sept/Oct timeline, and we will also be filling the COPS positions. Two vehicles will go to UPD and one to CID.

Akin Ford (state bid contract holder for Dodge) has submitted a bid on Three vehicles, Two 2009 Dodge Chargers and One 2005 (17000 miles) CV.
